This **Assessor** role will be home based in the Greater Belfast area to help make independent living a reality for many in Northern Ireland.

<u>ILF Scotland</u> values flexible working arrangements for employees. This position offers flexibility, with the opportunity to work full-time or job share at 35 hours per week. We welcome applications from those seeking to balance their career with other commitments while contributing to <u>ILF Scotland's</u> mission.







## **Your New Organisation**

ILF Scotland is a Non-Departmental Public Body (NDPB) constituted as a company limited by guarantee. It was created following the closure of the UK ILF in June 2015 and has been administering ILF funding for existing fund recipients in Scotland and Northern Ireland since 1 July 2015. The purpose of this funding is to enable independent living for disabled people, giving recipients control, choice and dignity. In late 2017, the Transition Fund (TF) was launched after major co-production, to support young disabled people between 16-25 in the transition after leaving school or children's services to be more independent, more active and engaged in their community, and to build and maintain relationships with other people.

ILF Scotland currently distributes annual funding through the Independent Living Fund and Transition Fund (TF) of approximately £55m alongside revenue budget of approximately £4M totalling around £60 million to support individual recipients lead independent lives. The organisation consists of a staff team of around 78 people, who provide independent living support for over 8,000 current fund recipients per annum split between the 2015 Fund (2,300) and Transition Fund (6,000).

The organisation is fully funded by and accountable to, Scottish and Northern Ireland Government Ministers via a Board of Directors.

Directors are appointed by Scottish Ministers in-line with the Scottish Public Appointments process.

As a values-based organisation, <u>ILF Scotland</u> takes a values-led approach to legislative compliance where people and relationship building are a key focus.







#### **Your New Role**

As a key role in <u>ILF Scotland</u>, you will be planning, organising, and conducting ILF award assessments and reviews throughout the Greater Belfast area.

You will be working directly with recipients, their families, and carers, collaborating with Health and Social Care Trusts and third-sector organisations ensuring our funding supports meaningful independent living outcomes and ensuring our vision for "Independent living to be a reality for all disabled people living in Scotland and Northern Ireland" is a reality for many.

You will construct tailored solutions that seek to address complex and individual needs and beyond the practical support, your work helps to champion the social model of disability and advocate for equality, diversity, and the rights of individuals in the communities we serve.

As an Assessor at <u>ILF Scotland</u>, you will conduct holistic, person-centred assessments and reviews that empower recipients with choice, control, and independence. Collaborating closely with Health and Social Care Trusts, social workers, and third-sector organisations, you will advocate for and deliver exceptional outcomes for these recipients.

Furthermore, in this role you will represent <u>ILF Scotland</u> as an ambassador, striving to build strong relationships with stakeholders and promoting the principles of <u>ILF Scotland</u> to achieve excellent outcomes with recipients, their families, and carers, ensuring choice, independence and social inclusion.
